- Secretary (currently held by Simon Bruce as appointee of the Board of Governors to fill the vacancy created by the resignation of William Longrigg and eligible for election)
- Two Governors at Large (currently Frances Hughes, finishing her second three year term of office and therefore not eligible for re-election and Carla Smeets, finishing her first full three year term of office and therefore eligible for re-election)

If a nomination creates a vacancy in any other office, the Nominating Committee will nominate a candidate for the open office. No member of the Nominating Committee is eligible for nomination.

The Nominating Committee will meet in conjunction with the European Chapter Meeting in Munich, Germany from 5th to 9th May 2010.

Fellows who wish to be considered for nomination or who wish to suggest other Fellows for nomination should do so, in writing (e-mail is an acceptable form), addressed to David Salter (with copies to the other members of the Nominating Committee and to the President, Ian Kennedy and Executive Director, Donna Goddard); nominations to be received no later than 11:00 p.m. GMT on 31st March 2010.
