**Re: Report of the Nominating Committee**

Pursuant to Bylaw 10.5:

- b. The petition shall:
  1. state that the Fellow nominated has consented to the nomination; and
  2. be sent to the President so that it is received not less than forty-five (45) days before the annual meeting.
- c. The President shall immediately advise the Nominating Committee, the other candidates and the Board of all nominations made by petition.
- d. The Secretary shall, before the annual meeting, publish a notice of all contested elections on the website, giving each candidate's name and address, with a brief statement of the candidate's activities in the Academy and, generally, in the legal professions. The notice shall also be sent to each Fellow, by whatever method is considered suitable, which may include email, not later than thirty days before the annual meeting.
